The Occupants must provide the following when coming to City Hall to complete the application: A valid ID is required for all adults 18 years and over (state issued identification is required); non-citizens shall provide passport or foreign identification card for all residents living at the property. All occupants must provide a valid birth certificate for occupants 17 and under.
